RADIOLOGICAL STATUS OF AMF/VOIT PROPERTY

In June, 1986, Bechtel National, Inc. conducted a radiological survey on your property on behalf of the U.S. Department of Energy. The purpose of this survey was to determine if radioactive contamination existed within your property boundaries. The results of this survey are complete and we are pleased to report that no radiological contamination was found.

The survey consisted primarily of radiation scanning of the ground surface to confirm the results of a previous survey of your property performed by NUS Corporation. No measurements exceeding guidelines were found.

Based on these results, your property will be removed from the DOE remedial action program by DOE headquarters. You will receive a letter confirming their action with the next few months. No radiological cleanup is required and no restrictions need be applied to activities on your property based on the findings of the DOE surveys.
