Subject: Maywood Site - Truck Route for Waste Transport

Dear Mr. Dominic:

This letter is to inform you of the proposed route for dump trucks hauling radioactively contaminated soil, non-DOT regulated, from Lodi residential properties to Maywood Interim Storage Site (MISS). The route by which empty trucks will return to the Lodi properties from MISS is also included. Maps showing alternative routes are attached.

The trucks used to haul the above material will be single and dual-axle dump trucks.

The safest route (and the one with the least impact on local traffic) for loaded trucks traveling to MISS from 79 Avenue B and 90 Avenue C is the following:

- Exiting driveway at 90 Ave. C property take a left onto Ave. C, proceed to Grant Street
- Right turn onto Grant Street
- Proceed up Grant Street to Ave. D
- Right turn onto Ave. D
- Proceed down Ave. D to Hancock Street
- Left turn onto Hancock Street
- Proceed up Hancock Street to Trudy Drive
- Left turn onto Trudy Drive
- Proceed up Trudy Drive to Main Street
- Turn right onto Main Street
- Proceed up Main Street across Essay Street onto Rachel Ave.
- Proceed up Rachel Ave. to West Central Ave.
- Right turn onto West Central Ave.
- Proceed down West Central Ave. to Maywood Ave.
- Right turn onto Maywood Ave.
- Proceed down Maywood Ave. to West Hunter Ave.
- Right turn onto West Hunter Ave. to Miss

The following route is for empty trucks traveling from MISS to the Lodi properties:

- Exiting MISS down West Hunter Ave. to Maywood Ave.
- Proceed down Maywood Ave. to Essex Street
- Right turn onto Essex Street
- Proceed up Essex Street to Main Street
- Left turn onto Main Street
- Proceed down Main Street to Trudy Drive
- Left turn onto Trudy Drive
- Proceed down Trudy Drive to Hancock Street
- Right turn onto Hancock Street
- Proceed down Hancock Street to Ave. C
- Tight turn onto Ave. C and to the property at 90 Ave. C
