RESULTS OF THE RADIOLOGICAL SURVEY AT 46 KIPP AVENUE, LODI, NEW JERSEY

INTRODUCTION

A radiological survey of 46 Kipp Avenue, Lodi, New Jersey, was conducted by a survey team from Oak Ridge National Laboratory (ORNL) on April 12, 1985 at the request of the Department of Energy (DOE). This property was identified as being suspected of having contaminated material present during the mobile gamma scan of Lodi, New Jersey.¹

The radiological survey conducted on this property was for the purpose of determining whether the property had any radioactive material onsite in excess of background radiation levels, and, if so, were these radioactive materials in excess of remedial action guidelines established by DOE such that the property could be "designated" for further investigation. This report summarizes the results of the "designation" survey performed on this property.

SURVEY METHODS

The radiological survey of the property included: (1) a gamma scan of the entire property outdoors; and (2) sampling of surface (0-15 cm)soil. No indoor survey measurements were performed. These survey methods followed the plan outlined in Reference 2. A comprehensive description of the survey methods and instrumentation has been presented in another report.³

SURVEY RESULTS

Applicable federal guidelines have been summarized in Table 1. The normal background levels for the northern New Jersey area are presented in Table 2. These data are provided for comparison with the survey results presented in this section. All direct measurement results presented in this report are gross readings at ground surface;

background radiation levels have not been subtracted. Similarly, background concentrations have not been subtracted from radionuclide concentrations measured in environmental samples.

Systematic and Biased Soil Samples

Systematic and biased soil samples were taken from various locations on the property for radionuclide analyses. Locations of the systematic (LJ21S) and biased (LJ21B) samples are shown in Fig. 1, with results of laboratory analyses provided in Table 3. Concentrations of uranium, radium, and thorium were within normal background levels in the systematic sample. However, concentrations were elevated above background in the biased soil samples with the highest radium concentration of 29 ± 2 pCi/g in sample LJ21B2B. Normal background concentrations of 232Th were found in all biased soil samples.

Gamma Radiation Levels

Results of the gamma scan of the surface of the property showed areas where gamma exposure rates are in excess of background radiation levels. Locations and exposure rates are shown in Fig. 2. These results locate areas where 238 U-bearing material exists. Gamma exposure rates up to 42 μ R/h exist on the surface of this property.

SUMMARY

Measurements taken at 46 Kipp Avenue indicate that the property contains radioactive contamination primarily from the 238 U decay chain. This material was found in the locations shown in Fig. 2. While the ratios of 238 U to 226 Ra are not in total equilibrium, it is believed that this is naturally-occurring material. Further investigation may be required to determine if this uraniferous material is an outcrop of uranium ore material which is native to this area of northern New Jersey.
