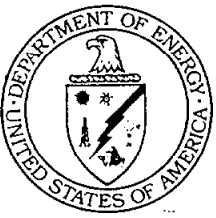

MAYWOOD SITE -- FORMATION OF COOPERATIVE GUIDANCE GROUP

As you know, the Department of Energy (DOE) is forming a stakeholder group in an effort to enhance cooperative planning and cleanup of the Maywood site. We have enlisted the services of Rutgers University's Center for Environmental Communication and a neutral facilitator, to work independently of DOE, in the development of this group.

The first step will be formation of a Steering Committee of eight to ten individuals representing Bergen County and the three affected municipalities. The primary responsibilities of the members of the Steering Committee will be to develop a mission statement, identify a representative membership, and develop meeting guidelines for the group. Steering Committee members may serve on the Cooperative Guidance Group but are not required to do so.

I have enclosed a list of individuals that are being invited to participate on the Steering Committee and, as an example, one of the letters being sent to a Steering Committee member. The letter states that you may be invited by the Steering Committee to participate in meetings in an advisory capacity.
