U.S ARMY CORPS OF ENGINEERS SEEKS PUBLIC COMMENT ON PROPOSED CLEANUP AT FUSRAP MAYWOOD SUPERFUND SITE PROPERTIES

The U.S. Army Corps of Engineers (USACE), New York District, is seeking comment on an Engineering Evaluation/Cost Analysis (EE/CA) report on a proposal to remove radiologically contaminated soil at several properties that are part of the FUSRAP Maywood Superfund Site (the "Site"). The Site is considered part of the Maywood Chemical Company Site placed on the National Priorities List by the U.S. Environmental Protection Agency. The proposal is known as a removal action under the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA). USACE proposes to conduct the removal in advance of several roadway improvement projects planned by the New Jersey Department of Transportation (NJDOT) that will impact contaminated soil at several properties that are part of the Site.

The EE/CA presents the need for a removal action under CERCLA, information on the affected areas at the Site, the cleanup alternatives that were considered, and the reasons for selection of the proposed removal action. Under this proposal, radiologically contaminated soil on the Site that are impacted by NJDOT activities will be removed, transported to the government-owned Maywood Interim Storage Site, and then disposed of at an authorized offsite facility.

The public is invited to comment on the proposed action through August 24, 2001. The EE/CA is available for public review at the FUSRAP Public Information Center, 75A West Pleasant Avenue, Maywood, (201) 843-7466. The information center is open Monday and Wednesday 9 a.m. to 4 p.m. and Friday 9 a.m. to 3 p.m. The information center will also be open from 6 to 8 p.m. on Tuesdays and Thursdays through August 24 to accommodate those who cannot visit during the day.
