NOTIFICATION OF NATURAL RESOURCE TRUSTEES

The U.S. Department of Energy (DOE) has been identified as a relevant federal natural resource trustee, along with the U.S. Department of the Interior (DOI) and the National Oceanic and Atmospheric Administration (NOAA). In addition, Section 107 of the Comprehensive Environmental Response, Compensation and Liability Act (CERCLA) provides for the designation of federal and state trustees who shall be responsible for, among other things, the assessment of damages for injury to, destruction of, and loss of natural resources.

As a trustee for natural resources located on, over, or under land administered by the United States and the State of New Jersey, this letter is to officially notify you as a co-trustee that DOE is planning to remediate sites designated for remedial action under the Formerly Utilized Sites Remedial Action Program (FUSRAP). The FUSRAP program involves cleanup of sites formerly utilized by the Manhattan Engineer District, plus other sites officially assigned to FUSRAP by Congress. Sites within the state of New Jersey which have been designated for remedial action under FUSRAP are listed in the Enclosure.

The remedial investigations which have been initiated may identify injury to natural resources resulting from activities of DOE and its predecessor agencies. The remediation work will be performed in accordance with decisions reached under the National Environmental Policy Act (NEPA) and CERCLA. Coordination of plans, studies, and assessments of remedial activities is currently being conducted by DOE. As a co-trustee for natural resources, DOE requests that you indicate how you wish to participate in future natural resource trustee activities.
