Re: Sunoco Service Station #0006-6357 Renovation, Eastside Route 17, Maywood
New Jersey

Please be advised that I am in receipt of your November 28, 1994 letter and received December 5, 1994. The request for permission to commence the Underground Storage Tank (UST) top and pipe upgrade is conditionally acceptable. The following items and/or concerns shall be addressed as applicable. The items are as follows:

1) The proposed disposition of concrete/asphalt rubble as well as steel salvage remaining after pad removal and piping retrofitting must be detailed. If said material is not used as construction backfill and disposed of offsite as waste, these materials shall be classified and disposed of in accordance with all applicable Federal, State and local requirements. Such requirements include mitigating potential radiological impacts.

2) The proposed backfill procedure is acceptable provided that such materials shall be free of petroleum product contamination. As stipulated in your correspondence, evidence of such contamination shall be reported to this office prior to New Jersey Department of Environmental Protection (NJDEP) approval of backfill operations. In addition, the location of backfilled materials shall be surveyed with coordinates of same supplied in a site map provided to this office for future reference.


3) Pursuant to N.J.A.C. 7:26E-6.2, Sun Company shall ensure that erosion and dust control are maintained and include real time perimeter wide monitoring to preclude potential release of materials and public exposure. Notwithstanding, Sun Company shall comply with all applicable sections of N.J.A.C. 7:26E pertaining to the proposed UST top and piping upgrade.

4) With regard to the Phase II investigation, the NJDEP agrees that this activity shall be delayed until such time that the United States Department of Energy has completed its remediation of area radiologically impacted soils provided that no documented release of petroleum product has occurred at this location. As stated above, in the event that such release is determined, Sun Company shall coordinate with this office to determine a suitable means of characterizing the extent of said release.
