An independent assessment of remedial action related activities at 18 Long Valley Road, a vicinity property in Lodi, New Jersey, has been accomplished by the Oak Ridge National Laboratory's Measurement Application and Development group. The purpose of the assessment is to verify the data supporting the adequacy of the remedial action and to confirm the site's compliance with remedial action criteria. The assessment included a verification survey of the property and a review of post remedial action data. Based on the review and the verification survey the site conforms to the remedial action criteria established for this site.
