In the interest of providing the results of radon flux monitoring in as timely a manner as possible, we will continue to submit future results of each semiannual monitoring event to EPA within 60 days of each sampling event. This time period is necessary in order to consolidate the monitoring results from all four FUSRAP sites within Region II into one transmittal.
